**1) ENTRIES:** I-\$260, P & T-\$220, PT&E-\$195. *HST, drug, ambulance, and "Building Ontario One Event at a Time" fees included in entry.* All levels please add \$10 CE Levy.

**Note:** a **photocopy of all current memberships MUST accompany entry. Completed entries received after the closing date will be subject to a \$30.00 late fee.** REFUNDS:

Before May 20, refund less \$30 admin fee; after May 20 NO REFUNDS. NO EXCEPTIONS. Stabling refund before May 13 unless stall can be filled. Withdrawals must be made in writing via email or fax. Telephone withdrawals will not be accepted. Entries may be accepted after closing date with \$30 late fee. Neg. Coggins Test required within 12 months if stabling. Competition cancellation no refunds. Cheques payable to Grandview Horse Trials. NO POST DATED CHEQUES. Incomplete entries will be returned. No payment by Closing Date= Entry not accepted.

**2) TIME SCHEDULE:** May 25, 3:00pm - course and office open. May 26, 8:00am - [E,PT] dressage; 10:00am - [E,PT] show jumping; 11:00am - [E,PT] XC. May 27, 8:00am - [I,P,T] dressage; 10:00am - [I,P,T] SJ; 11:00am - [I,P,T] XC. Start times available May 24 at [www.grandviewfarm.com](http://www.grandviewfarm.com). Entry status available approx. May 18

**3) OFFICIALS:** TD: Bill McKeen; XC CD/CB: Bob Holman; Stad.CD: Sarah Irving; JUDGES: DRESSAGE, SHOW JUMPING: TBA.

**4) STABLING:** Stabling very limited- enter early for on-site stabling, 20 new 10x10 portable stalls only. \$60 incl. HST/stall per night (6pm-6pm). Stall doors, initial bedding provided. Stalls must be cleaned out before leaving. If on-site is full then call for local stabling availability.

**5) DRESSAGE:** I: FEI CCI/CIC 2\* Test A; P: FEI CCI/CIC 1\* A; T: Test 1; PT: Test 1; E: Test 1. ARENAS: I, P -20x60m; T, PT & E -20x 40m. Sand/ Future Track footing.

**6) CROSS COUNTRY:** I-3000m@550mpm; P-2800m@520mpm; T-2400m@ 450mpm; PT-2000m@400mpm; E-1800m@350mpm. TERRAIN: Excellent early season sandy footing, rolling terrain. All courses inviting; always adding new jumps at all levels. **Please Note: Entry Cross Country will now be timed and penalized**

**7) AWARDS:** Plates or coolers to winners. Ribbons to 8th place.

**9) DIRECTIONS:** From Hwy 11 North of Barrie to Oro Line 9; go over overpass West to Bass Lake Road (3rd stop sign). At 'T' junction, turn right and .5 km to Oro Line 10. Turn left to 2<sup>nd</sup> farm on right 1km. From Hwy 400, take Horseshoe Valley Road East past Coulsen to 10th Oro (at Jarratt). Turn right on 10th. Farm 2km on left.

**10) OTHER INFORMATION:** Vet on grounds during endurance, farrier and medical on grounds all day. Refreshments available on grounds. Children **must** be accompanied by a responsible adult. Dogs are welcome but must be on leash. Loose dog fine of \$50 will be donated to Course Building Fund. Stabling sometimes available for other events in the area. All competitors must have pinny holder. New enlarged showjumping ring with new footing for 2012! Additional parking added in south corner of property with new entrance
